Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, we would like to inform that Ishan International Limited has signed a subcontract with Rite Water Solutions (India) Private Limited for supply, installation, commissioning, and maintenance of agricultural submersible pumps under the popular Pradhan Mantri Kisan Urja Suraksha evam Utthan Mahabhiyan Yojna (PM-KUSUM YOJNA). These pumps are designed to operate on solar power, reducing the dependency on diesel and grid electricity, thereby lowering operational costs for farmers and promoting sustainable agricultural practices.
